Overview of ATSIEB

In August 2011, the second term three-year term of the Aboriginal and Torres Strait Islander Elected Body (ATSIEB) commenced. The elected members embraced responsibility for engaging with and representing the needs and views of all Aboriginal and Torres Strait Islander peoples living in the ACT. The ATSIEB members also informed ACT Government policy initiatives and development and suggested improvements of services to our peoples in the community.

Original elected membership of the second ATSIEB group included: Rod Little (Chair), Diane Collins (Deputy Chair), Brendan Church, Roslyn Brown, Lynette Goodwin, Benny Hodges and John Paul Janke.

During this tenure of office, Benny Hodges and John Paul Janke offered to voluntarily vacate their positions as elected members due to other commitments.

Masepah Banu and Maurice Walker were subsequently installed as two new members by the Minister for Aboriginal and Torres Strait Islander Affairs.

The statutory tenure of all current seven elected members will conclude, prior to the announcement of the upcoming ATSIEB elections.
